- Complete the QP0515 Statement of Eligibility application form and lodge it at your local police station.
- You will receive the Statement of Eligibility from Weapons Licencing by mail.
- Bring the statement with his completed form, and ID to the club in order to join.
- Please note the Statement of Eligibility is valid for 90 days only. You must join the club before this time.
